- 1) The pipe penetration consists of a penetration piece and two bite connectors made of SUS316/SUS316L and welded to bulkheads and decks symetrically.

- 2) The size of penetration piece is as follow; ADBUW Type: L Series (6 mm ~ 35 mm) & S Series (6 mm ~ 38 mm) ACBUW Type: Fractional size (1/16" ~ 1-1/2") & Metric Size (2 mm ~ 38 mm)
- 3) Tested penetration size(dia.) : 6 mm, 15 mm, 38 mm
